#### **SCHOOL SAFETY COMMITTEE (SSC)**

At Dr. Jacobs Hitech School, the safety, security, and well-being of our students, staff, and visitors are of paramount importance. In accordance with CBSE guidelines and in the interest of creating a safe learning environment, the **School Safety Committee (SSC)** has been constituted under the supervision of **Rev. Fr. Antony Kanagaraj, Principal**. This committee is tasked with ensuring that all safety measures and emergency protocols are implemented, monitored, and reviewed regularly.

#### **Objectives**

- **Ensure a Safe Environment**: Maintain a secure, hazard-free campus and learning environment.
- **Emergency Preparedness**: Plan and execute regular safety drills and crisis response training.
- Preventive Measures: Identify and address safety hazards proactively.
- **Monitor Infrastructure Safety**: Oversee building, transportation, and electrical safety.
- **Health & Hygiene**: Promote cleanliness, sanitation, and health awareness among students and staff.
- **Child Protection**: Ensure compliance with POCSO Act, anti-bullying policies, and other child safety laws.

## Scope of Work

The School Safety Committee will oversee the following areas:

- Infrastructure and building safety audits
- Fire safety equipment installation and maintenance
- Safe transportation policies and practices
- Prevention of child abuse, bullying, and ragging

- First aid and health emergency protocols
- Training of staff and students in emergency response
- Ensuring compliance with CBSE and local safety regulations
- COVID-19 / seasonal health protocol implementation (if applicable)

### **Reporting Mechanism**

- **Immediate Safety Concerns**: To be reported to any staff member or directly to the Safety Committee.
- **Emergency Situations**: To be escalated to the Principal or Administrative Officer immediately.
- A suggestion box is available in the Administrative Block for safetyrelated feedback or anonymous concerns.
